Invitation for Bids for the **Construction of 15 Bed Hospital Building at Mahottari Rural Municipality, Mahottari**

1. The Government of Nepal (GoN) **has allocated funds** or received grant from **GoN** towards the cost of **Construction of 15 Bed Hospital Building at Mahottari Rural Municipality, Mahottari** and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible as per Section V of bidding document.
2. **Office of the Mahottari Rural Municipality**, Mahottari invites electronic bids from eligible bidders for the **Construction of 15 Bed Hospital Building at Mahottari Rural Municipality, Mahottari** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Rs. 14,20,00,000.00**
 - Minimum Work experience of similar size and nature: participation as prime contractor, management contractor, or sub contractor , in at least **two(2)** contract within the last ten (10) years, with a value of at least **Rs. 15,10,00,000.00** in hospital building with all complete work projects that have been successfully or are substantially completed and that are similar to the proposed works.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Mahottari Rural Municipality, Mahottari, Mahottari or may visit PPMO e-GP system www.bolpatra.gov.np/egp
 5. The Bidders may obtain a complete set of Bidding Documents at the office of Mahottari Rural Municipality or may visit PPMo's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Antrik Rajaswa Khata as upon payment of a non-refundable fee of **Rs 10,000** specified below as per table during office hours till 11th Nov. 2021 before 12:00 PM

6. Pre-bid meeting shall be held at Mahottari Rural Municipality office, Mahottari, Mahottari at 1st Nov. 2021 at 01:00 PM
7. The bid must be submitted to the office of Mahottari Rural Municipality, Mahottari through PPMO's e-GP system www.bolpatra.gov.np/egp on 11th Nov. 2021 before 12:00 PM.
8. Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **02:00PM 11th Nov. 2021** at the office of **Mahottari Rural Municipality, Mahottari..** Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,) amounting to a minimum of **Rs 53,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid (***i.e. 120 days) from the date of bid opening.***
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
11. Mahottari Rural Municipality, Mahottari reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
